**HHS seeks comment for grant funds**

Broomfield's Health and Human Services (HHS) Department will apply soon for Community Services Block Grant (CSBG) funds for March 1, 2006 through February 28, 2007. Public comment is required as part of the application process.

Copies of the proposed plan will be available for public comment on Wednesday, January 25, 2006 from 8 to 11 a.m. at the HHS Building, 6 Garden Center.

Federal CSBG funds are made available to organizations to provide services for low-income families and children. Grantees must demonstrate that the community has recipients who are below 125 percent of the federal poverty level. CSBG funds for Colorado are distributed through the State Department of Local Affairs Community Services Block Grant Program Office.

**Ongoing audit plan, state law call for home inspections, fair property values**

For the next five years, to stay in compliance with state statutes, Broomfield appraisal staff will be tackling home inspections to make sure that assessments throughout the community are fair.

During the next five years, the staff will work each year to review 2,000 homes that have not sold in the previous four years.

Colorado state statutes require all county assessors to equitably value all property within their county. To accomplish this, assessors inspect all property on a routine basis.

Starting this month, Broomfield appraisers will be inspecting residential property that has not sold in the last four years. This includes single family residential, town-homes and condominiums. These inspections are part of Broomfield's audit plan to stay in compliance with state requirements, according to Assessor Vickie Brown.

Anyone with questions or concerns during this inspection process may contact Brown at 303-464-5819.

All appraisers will be wearing apparel that has the City and County of Broomfield logo and will present identification at the door. They will ask the owner if an interior inspection can be done. If the owner does not allow the appraiser entry, appraisers will present a data sheet for the owner to fill out and mail back. At no time will any appraiser insist on entry or harass the homeowner to gain entry into a home.

If the owner is not at home, the appraiser will leave the data sheet on the door, take a picture and assess the exterior of the home. An exterior physical inspection measures the exterior perimeter of the home, notes the type of architecture, type of siding, roof cover, type of cooling (central air or swamp) and pictures are taken to supplement documentation.

Interior inspection consists of the number of bedrooms, baths, fireplaces or wood stoves, type of heating (forced air, hot water, electric) and basement

finish. Other additional features include swimming pool, tennis court, covered or enclosed patios and wood decks.

### ***Spring Earth Day activities on calendar in utility bills***

The calendar lists dates and times for the many popular programs, including the Computer Recycling Day, Xeriscape Seminars, Household Hazardous Waste Drop-off Day and the new Curbside Spring Clean-up program.

### ***State tax check-off helps residents contribute to homeless prevention***

Tax preparation time is here, and Broomfield residents filing Colorado state income tax returns can help prevent homelessness right here in Broomfield.

Taxpayers can make a contribution to prevent Broomfield residents from becoming homeless through the Homeless Prevention Act Program (HPAP) tax check-off on state income tax returns. The program is administered through the Colorado Trust, and funding is awarded through an annual competitive bid process. Funds from this year's check-off will be awarded for 2006-07.

For 2004-05, Broomfield Health and Human Services (HHS) received funds to provide direct intervention to 28 people in eight Broomfield families. For 2005-06, Broomfield's award was increased, allowing HHS to prevent homelessness for 43 people in 11 families.

All of the HPAP funds awarded to Broomfield went toward direct payments to landlords on behalf of eligible families to prevent their eviction. Broomfield HHS partnered with FISH, the Broomfield Community Foundation and Emergency Family Assistance Association (EFAA) to leverage HPAP funds so that more families could be served. At this time, the 2005-2006 Homelessness Prevention Program Activity funds have been fully spent. New HPAP funding will not be available until October 1, 2006. Broomfield residents can voluntarily contribute to HPAP by checking the HPAP box on their state returns. The more money that is contributed to this program, the more resources will be returned to serve Broomfield residents in need.

### COMMUNITY DEVELOPMENT

**Lowell Boulevard utility improvements:** A neighborhood meeting for the Broadlands community earlier this month in the Bal Swan/Zang Spur Conference Rooms brought approximately 30 attendees.

The Lowell project is developer-financed with some Broomfield reimbursement from funds received from the development as it occurs.

A citizen suggested leaving gates on Augusta Drive/Fairway Lane open during construction hours, and the Broadlands HOA will investigate if this is possible. The contractor will coordinate right-in and out access to the golf course maintenance facility.

Broomfield was requested to monitor increased traffic volume and speeding along Broadlands Drive during construction and a citizen wanted Broomfield to install 25 mph speed limit signs on Broadlands Drive. Broomfield will investigate and place signs as needed.

Several residents were concerned that the work would widen Lowell Boulevard by installing additional lanes. Staff responded that the roadway will be returned to the same roadway section that exists today. Staff will also send residents notification with an updated construction schedule in February; and will conduct a follow-up neighborhood meeting with

the Broadlands residents, anticipated in March, to solicit additional input/feedback.

### COMMUNITY RESOURCES

**Recreation Services:** The **gymnastics staff** gave parents a "Holiday Childcare Shopping Break." Four sessions were offered the week of December 19. This first-time offering was highly successful, registering 51 children who had a great and safe time expending their excess pre-Christmas energy on the gymnastics equipment. Parents and children alike gave a very positive response to the classes.

The **Early Learning** families were very involved with the "Giving Tree" project through ERC and building coordinator, Carolyn Johnson. The tables and counters of the Paul Derda Recreation Center (and Nancy Harrold's office) were covered with holiday gifts for needy families in Broomfield.

Also in December, parents of children enrolled in the Early Learning program were given assessments on their children, letting them know of their progress in class.

During the month of December, **Senior activities** included trips to Celestial Seasonings, Heritage Square Dinner Theater, Carrabba's and Bull Durham Casino. There were 91 participants, and the proverbial "good time was had by all." Participation in senior programs including SilverSneakers®, Arts and Crafts, Fitness, drop-in activities, and special events totaled 420 individuals.

**Special events** included the Winter Wonderland Dance, which was opened to all family members this year as opposed to grandparents and grandchildren only, as in the past. There was a live band and 54 people enjoyed dinner, crafts and dancing.

The annual Tree Lighting Ceremony had approximately 400 people in attendance. Six singing groups performed, and Santa flew in on a helicopter (landed in the parking lot of the Bay). Families enjoyed the entertainment, kettle corn, and hayrides.

About 75 youngsters received a call from Santa in the Talk to Santa event this year. For this program, parents complete and return a form for each child

who then gets a call from Santa on a Saturday morning. This year, Paul Derda and George Atencio helped out, lending their voices to Santa.

In the **youth and teen** program, Dawn Clinton, recreation specialist, keeps interest and enthusiasm high in the "School's Out" program. December's class had 51 participants who had a "totally" great time.

In **athletics**, Youth Basketball is well under way. There are 1,450 kids playing basketball in 125 recreational 16 competitive teams for cagers in grades K-8.

The **Fireworks Softball Tournament** this July is already full with 85 committed teams, 15 teams on the waitlist, and numerous others who have been turned away because their chances of actually securing a spot in the tournament are unlikely.

### **HEALTH AND HUMAN SERVICES (HHS)**

**New employee:** Mirna Castro joined Health and Human Services at the front desk reception area last month. She hails from Boulder County and brings extensive customer skills and bilingual services. On average, 55 clients come to the HHS front desk daily, and many of these clients are Spanish speaking. HHS is pleased to have Mirna on the team.

**CBMS recognition:** As a follow-up to the Colorado Counties Inc. conference, HHS staff continues to navigate through the Colorado Benefits Management System (CBMS) difficulties, providing services to customers and serving as stewards of government funds. The success of this effort is exemplified in an award received from the director of the Food Stamp Quality Assurance Program. Broomfield was recognized for having no Food Stamp errors in the third quarter.

**Job fair:** The second annual Youth Job Fair is scheduled for Tuesday, Feb. 21, at the Paul Derda Recreation Center. Any businesses that would be potential employers or serve as a resource for the youth are encouraged to contact Celia Hardin at the Workforce Center, 303-464-5855. Last year's fair brought in over 1,000 youth and parents.

**New hours:** The Vital Statistics Office at HHS has new office hours. Effective the first of this year, the

office is open from 9 a.m. until 4 p.m. Monday through Friday.

**Giving Tree:** The Family Connections Giving Tree Program provided gifts to 398 individuals during the holiday season. Local companies such as MWH Constructors and Check into Cash, local churches, church youth groups, students at Ryan Elementary School and Mandalay Middle School, and community members joined city and county staff in adopting 103 families.

The 103 families were clients at HHS and were referred by the Workforce Center, Family and Children's Services, TANF, the WIC clinic, and Senior Services.

**4-H update:** In the last two months, 47 kids have signed up as members of the Broomfield 4-H program. The Colorado State University Extension Program is hoping to have 100 members in its first year.

**Senior deliveries:** 60 Blizzard Packs were made and delivered to local seniors in case they are snowed in due to bad weather. The packs contain non perishable items that seniors can use if they are not able to get to the Lakeshore Café for lunch or Meals on Wheels is unable to deliver lunch due to severe weather. The Safeway store on Main and 120<sup>th</sup> Avenue donated 60 jars of peanut butter which were added to crackers, apple sauce, juice, bottled water, and other items.

**Tobacco Partnership:** The Broomfield Tobacco Education and Prevention Partnership is offering businesses in Broomfield the opportunity to save money. The Partnership offers free "train the trainer" sessions so employers can facilitate a quit-smoking class for employees. Also available free are cessation materials on a monthly basis, and a Tool Kit entitled "Profits and Productivity going up in Smoke?" - a guide to decrease the business costs associated with smoking.

Tobacco use costs employers \$3,400 per employee per year. Employers are paying through health insurance premiums, decreased productivity, absenteeism, disability and workers compensation claims. For more information, call 720-887-2276.

**Gift from Target:** HHS has received \$6,000 from Target to form a community partnership supporting three HHS programs: Nurturing Parenting, Quality

Child Care Expansion, and Tenant-Based Rental Assistance (TBRA).

Funds donated by Target will be leveraged with state and local resources to improve the quality of life and livelihood of Broomfield's citizens through enriched reading programs, improved parenting practices and access to education and skill development training. This grant is part of the ongoing support Target provides to local communities throughout the country.

**Thriving Communities grant:** HHS has been awarded \$45,000 to carry out implementation plans of the Thriving Communities (Healthy Eating and Active Living) Initiative.

The initiative will focus on partnerships to include strategies with Open, Space and Trails to improve neighborhood trail connectivity, assisting schools with plans and policies that support nutrition and physical activity and focus on key findings from the community-wide survey conducted in October of 2005.

**Comprecare grant:** The Board of Directors of the Comprecare Foundation, Inc. has awarded HHS \$10,000 to sustain its efforts in preventing unintentional injuries among older adults in Broomfield. The funding will be used to provide fall risk assessments, home modification equipment and professional services from occupational therapists.

**Breastfeeding grant:** Broomfield WIC has been awarded a grant through the state Health Department's Colorado Physical Activity and Nutrition Program's Breastfeeding Taskforce. Breastfeeding infants for up to six months has been linked to a lower incidence of obesity in adolescents.

The Broomfield WIC Program has initiated a six-month breastfeeding support group to both Spanish-speaking and English-speaking WIC participants who

have made it their goal to breastfeed for six months and beyond. The support group is designed to develop an atmosphere conducive to sharing personal experiences, knowledge and support around breastfeeding and nutrition.

The grant dollars have made it possible to provide clients with breast pumps on an as-needed basis, as well as incentives such as baby bath items and a breastfeeding guide book. The support groups will continue through the month of April. More information is available from Rene Lindeen at 720-887-2258.

**Program under way:** The Nurturing Parents Program at Health and Human Services began its second session last week. Nurturing Parents is a 16 week family-based program that is offered free of charge to Broomfield families. The parenting class is run in collaboration with the Mental Health Center serving Boulder and Broomfield counties.

Nurturing Parenting emphasizes the importance of raising children in a warm, trusting and caring household. It is founded on the belief that children who are cared for develop the capacity to trust, care, and respect themselves, other people, living creatures and the environment. Outcomes for parents from the initial class include an increased understanding of children's growth and development, improved communication skills, and increased knowledge of appropriate discipline techniques. There were 17 parents and 11 children enrolled in the initial sessions.

**Training:** A training on Fetal Alcohol Syndrome will be offered to HHS families to assist parents in identifying a child who suffers from the syndrome. The training is Saturday, Jan. 28, at the Mamie Doud Eisenhower Public Library from 8:30 a.m. to 12:30 p.m. For information, contact Stephanie Rivale at 720-887-2238.

## Capital improvement projects

### Sheridan Boulevard update

The decorative concrete contractor, Colorado Hardscapes, is completing the colored-concrete in

the roadway medians. If the weather remains

warm, the work should be completed by early February.

The landscape contractor is following right behind, installing the irrigation system and plants and trees in the medians. If the weather remains mild, this work is on target to be completed by mid to late February. The remaining work will include sodding the west side of Sheridan south of W. 136th and

along both sides of Sheridan north of W. 136th Avenue. Sod will not be installed until the irrigation system is activated in the spring.

The original contract completion date for the project was May 23, 2006. All work, including the sod installation, should be completed well ahead of time.

### ***CIP Open Space projects***

The southeast quadrant of the Field is complete. You will see the artist doing some carvings on the benches in the next month as weather permits.

The Ridgview Trails are complete and available for use. The contractor has some final clean up and seeding to complete when weather allows.

The trails at the Broomfield County Commons are complete and open for use.
