NEW BUSINESS

Proposal to name facilities for John Ferraro and Bob Prince. At the April 12, 2011 City Council meeting, Broomfield residents John Long, Don Fankell, Pat Murphy and Tim Clifford submitted a petition requesting the recognition of Bob Prince and John Ferraro by naming facilities in their honor. Specifically, they suggested naming the gym at the PDRC for John Ferraro and the gymnastics room for Bob Prince.

After discussion, City Council decided to discuss naming procedures at a Study Session on April 19. As a result of that discussion, the City Attorney's office set out to establish guidelines for naming public facilities. These guidelines were approved at the May 24, 2011, City Council meeting.

A proposal addressing the guidelines (attached to minutes) has now been received from the citizens that had originally proposed the naming of the facilities. The proposal notes John and Bob’s involvement in and contributions to the community.

Discussion followed and Doug moved to support the recommendations of the four citizens to name the two facilities the “John Ferraro Gymnasium” and the “Bob Prince Gymnastic Center.” Larry seconded the motion and it was unanimously approved.
