REQUIRE A MANDATORY COURT APPEARANCE**

**JUVENILES – ALL PERSONS UNDER THE AGE OF 18 MUST APPEAR IN COURT WITH A  
PARENT/GUARDIAN ON ALL VIOLATIONS**

**TRAFFIC VIOLATIONS (2, 3, & 4 POINTS):**

(On all traffic violations, add an additional \$5.00 per point for an accident and/or subsequent violation)

1<sup>st</sup> VIOLATION within two years.....\$25.00 per point  
2<sup>nd</sup> VIOLATION within two years.....\$30.00 per point  
3<sup>rd</sup> VIOLATION within one year.....**MANDATORY COURT APPEARANCE**

**ALL ACCIDENTS**

**MANDATORY COURT APPEARANCE**

1<sup>st</sup> Violation within two years with accident.....\$30.00 per point

**\*\*\*ON ALL TRAFFIC CHARGES, FINES WILL BE BASED UPON ORIGINAL CHARGE\*\*\***

**ON ANY TRAFFIC VIOLATIONS IN A CONSTRUCTION OR SCHOOL ZONE,  
FINES WILL BE DOUBLED BASED ON ORIGINAL CHARGE,  
AND WILL REQUIRE MANDATORY COURT APPEARANCE**

**NO PROOF OF INSURANCE – 1<sup>st</sup> violation.....\$500.00**

Parking Violation – Handicap only.....\$50.00	All other parking violations.....\$25.00
Seat Belt Violation.....\$25.00	Child Restraint.....\$50.00
Obstructed Window.....\$25.00	Misuse of Wireless telephone.....\$50.00
Off Road Vehicle.....\$50.00	

All fines assessed may be increased or decreased, if there are mitigating or aggravating factors at the time of sentencing.

Safety Standard violations – each count	\$ 75.00
Overweight violations – each 1,000 pounds in violation or fraction thereof	\$ 50.00
Length violations	\$ 30.00
Deviation from established truck route	1 <sup>st</sup> offense.....\$100.00
	2 <sup>nd</sup> offense.....\$200.00
	3 <sup>rd</sup> offense.....\$300.00

**ANIMAL VIOLATIONS:**

**UNLAWFUL DOG ATTACKS**

- 1<sup>st</sup> violation (no injury)
- 2<sup>nd</sup> violation (no injury)
- 1<sup>st</sup> violation (injury)
- 2<sup>nd</sup> violation (injury)

**MANDATORY COURT APPEARANCE**

- \$150 MANDATORY MINIMUM & Additional penalties
- \$450 MANDATORY MINIMUM & Additional penalties
- \$300 MANDATORY MINIMUM & Additional penalties
- \$750 MANDATORY MINIMUM & 5 days jail & animal destroyed & Additional penalties

DOG AT LARGE.....	1 <sup>st</sup> violation.....	\$50.00
COLLARS.....	(For Collars and Tags, if defendant provides proof of compliance to the Prosecuting Attorney, the case will be dismissed).....	\$25.00
TAGS.....		\$25.00
DISTURBING THE PEACE/BARKING DOG	1 <sup>st</sup> violation.....	\$100.00
IMPOUND FEE.....	1 <sup>st</sup> violation.....	AMOUNT ON TICKET & 35.00 FINE


