

PLEA BY MAIL PROGRAM

The following plea offers are authorized by the Broomfield Municipal Prosecutor for all tickets for which there is no mandatory court appearance. The point assessments are intended to reward good drivers when appropriate, while still holding all defendants accountable for their driving violations.

ADULT PLEA BY MAIL: (Age 18 years and older)

<u>Original Ticket</u>	<u>Clear DMV Record for Prior 24 Months</u>	<u>1 or 2 Prior Violations in Prior 24 Months</u>
4 point	2 points (<i>Def Vehicle</i>)	3 points (<i>Special Hazards</i>)
3 point	1 point (<i>Def Headlamp</i>)	2 points (<i>Def Vehicle</i>)
2 point	0 point (<i>Def Tail Light</i>)	1 point (<i>Def Headlamp</i>)
0-1 point tickets remain the same and may be paid by mail		

*****ON ALL TRAFFIC CASES, FINES WILL BE BASED UPON ORIGINAL CHARGE*****

THE PLEA BY MAIL PROGRAM DOES NOT APPLY TO JUVENILES.

THE PLEA BY MAIL PROGRAM DOES NOT APPLY TO ADULTS IF THE CURRENT CHARGE IS:

- Any 6 point Speeding ticket of 20 mph or more over limit
- Any violation above 5 points
- No Proof of Insurance
- Careless Driving
- Any violation involving an accident
- If Defendant has 3 or more prior traffic violations within the previous 24 months
- Speeding in a School Zone or Construction Zone
- Stopping for School Buses

OVERWEIGHT VEHICLES AND SAFETY VIOLATIONS:

Overweight Vehicles - Both Gross Weight (508) and/or Axle Load Overweight (507) - \$50.00 for each 1,000 pounds or fraction thereof (Example: 1400 pounds overweight: \$50x2=\$100 fine)

Safety Standard Violations – \$75.00 for each separate violation

OTHER TRAFFIC VIOLATIONS:

Parking	\$25.00	Seat Belt	\$25.00
Handicap Parking	\$50.00	Child Restraint	\$50.00
Off Road Vehicle	\$50.00	Obstructed Windows	\$25.00


THE FOLLOWING FIRST VIOLATIONS CAN BE PAID BY MAIL IF DEFENDANT ENTERS A GUILTY PLEA TO THE ORIGINAL CHARGE. Any second and subsequent violation requires a MANDATORY COURT APPEARANCE.

<i>Collars</i>	<i>(For Collars and Tags, if defendant provides proof of compliance to the prosecuting attorney, case will be dismissed)</i>	\$ 25.00
<i>Tags</i>		\$ 25.00
<i>Disturbing the Peace/Barking Dog</i>		\$100.00
<i>Impound Fee</i>	<i>AMOUNT ON TICKET &</i>	\$ 35.00
<i>Open Container</i>		\$100.00
<i>Littering</i>		\$ 75.00
<i>Urinating in Public</i>		\$100.00

All payable fines and plea by mails will also be assessed \$20.00 in court costs and 10% fine surcharge.
