Holiday Rates are 1 ½ x above fees and apply to use scheduled during observed City and County of Broomfield holidays **and** all calls before 7 am and after 11 pm.

BASIC FEE INCLUDES

Standard lighting plot, sound system, 2 microphones, 1 technician; 60 music stands and chairs; 6 tables; public event internal marketing support e.g. web, cable, print event calendars, artsline.

Additional publicity is the responsibility of renter as are ushers and ticketing services.

Sound System includes 2 microphones of choice from available inventory, media playback -tape deck, CD player, mixer, speakers, monitors and intercom.

LIABILITY INSURANCE INFORMATION REQUIRED BEFORE DATE(S) ARE RESERVED

- (1) Applied to each rental and refunded per condition of facility after use; may be used toward additional fees or damage incurred during use as determined by Cultural Affairs
- (2) Applied to total fees due; full amount due if rented within 30 days of first date of use -no refunds
- (3) Copy of IRS or State of Colorado incorporation letter required to confirm nonprofit status
- (4) Applied when a full strike or restoration of standard light plot does not take place during rental
- (5) Rented if auditorium is not in use; two-hour minimum; food and drink allowed; proof of insurance, damage deposit, permits required; capacity 100 standing or 50 seated in rows; includes 1 staff
- (6) Discounts can't be combined; excludes equipment fees/damage deposit; 50% due with contract

Rates are subject to change and estimated as listed on request form. Total fees due are calculated after use. Broomfield reserves the right to refuse and/or terminate facility use.
