When to apply:

Legal Issues Clinics are available Monday through Thursday @ **1:00 p.m.** and on Friday at **11:00 am**. The clinic is located outside Courtroom 3 in the Client/Attorney conference room on the left. Most hearings for the protection orders are held at 3:00 p.m. daily. Otherwise, ask the Clerks of the Combined Court for availability of times when protection order requests can be heard by a Judge.

Cost:

Filing fee is free for victims of Domestic Violence, Stalking, or Sexual Assault. Service is free if Protection Order is served by the Civil Unit of the Broomfield Police Department.

\$35.00 for all other restraining orders (plus \$2 mileage fee)
