OLD BUSINESS

The Holy Trinity Church has been approved to become the upstairs resident in the Brunner Farmhouse. They have not moved in yet, but are expected to move in in the next few weeks.

1. HOUSE REQUESTS: The Brunner Family would like to use the Brunner House on 28 September for a family gathering and meeting to commemorate Ila Brunner who died on 30 August 2013. The Request was APPROVED.
2. GROUNDS AND GARDENS:
 - a. It was noted the YELLOW garden looks disheveled. It is maintained by SEW AND GROW. .
 - b. It was also noted that both the ORANGE and RED garden look very nice by comparison.
 - c. It was noted the ROSE garden is looking very good. Several rose bushes were replaced with new bushes by Renee Sereff. The garden is maintained by Renee and the Kozisek Family.
 - d. We still need a volunteer to maintain the Perimeter garden.
 - e. The ASI sign was put up by David Lewis in the Foundation garden.

4. FINANCES: The Brunner Farmhouse account balance is \$7471.96 as of 5 SEP 2013.

NEW BUSINESS

3. The Railroad Station Bench: Kevin advised us that the Railroad Depot Museum would like to have their bench returned to them. It was agreed to return the bench. Adequate funds exist to purchase additional folding chairs if

Diana Hastings suggested a sign be posted to remind Users of the house that we don't have professional cleaners and to "PLEASE Clean Up after yourselves".

Sherill will speak to the Group Leader of the Narcotic Annon Group that uses the house on Friday evening to remind them to clean-up after themselves.

6. Mary reported that the MICE are back in the basement of the Farmhouse. Kevin Standbridge said he believes City exterminators should be around regularly.
