Addendum to the Abstract of Votes Cast
November 5, 2013 Coordinated Election**

The undersigned members of the Canvass Board submit the following table as an addendum to the Abstract of Votes Cast for the November 5, 2013 Coordinated Election. The purpose of the addendum is to identify voters impacted by Colorado Secretary of State Election Rules [8 CCR 1505-1] 2.2.2 and 2.2.3, as temporarily adopted October 9, 2013 and permanently adopted November 14, 2013:

2.2.2 If the elector submits an application and does not include the date he or she moved, the county clerk must use the date the application is received or postmarked, whichever is earlier, as the date moved. If the elector submits the application during the 22 days before election day and does not provide the date he or she moved, the county clerk must use as the date moved the twenty-second day before election day based upon the affidavit.

2.2.3 In accordance with section 1-2-104, C.R.S., if a municipality, special district, or school district coordinates with a county clerk to conduct an election, the county clerk must apply the residency requirements of the municipality, special district, or school district. Nothing in these Rules supersedes any durational-residency or other requirements in local charters, ordinances, or titles 22, 31, or 32, as applicable.

Voters whose eligibility to vote on municipal contests was not established by the effective date of registration were sent an affirmation intended to clarify the date they moved to their current address. Post election, a review was conducted by Broomfield staff of 507 voters who voted in the election and were impacted by the residency requirements and affirmation mailing. Staff findings are included in the table below.

The table below is based on Broomfield staff research conducted after the initial certification and prior to the recount. It is current as of December 1, 2013.

- (GROUP A) Six voters whose votes on municipal contests should have been counted, but were excluded based on the voters' responses to the residency affirmation.
- (GROUP B) Five voters who lived in Broomfield long enough to vote on the municipal contests, but were excluded because they did not return the residency affirmation.
- (GROUP C) Six voters whose votes on municipal contests were counted, but whose voter registration records does not show evidence that they lived in Broomfield long enough to vote on the municipal contests.
- (GROUP D) One voter whose ballot was processed correctly having affirmed his residency after the deadline to affirm.
